Order - Sections 46 and 47

Redeclaration of Roads in the Wollongong City Council
Local Government Area.I, the Minister for Roads, pursuant to Section 46 and 47 of
the Roads Act, by this Order: Main Road No 678

- a) Vary the route of State Highway No 1 and Main Road No 185 by revoking the previously published declarations of these roads and declaring as State Highway No 1 - Princes Highway and Main Road No 185, the roads described in the schedule below, and
- b) Declare as Main Road No 678 the route described in the schedule below.

southbound ramps at Helensburgh Interchange, then south along the former Princes Highway to the junction with the Southern Freeway northbound ramps.

Old Princes Highway - From intersection with Princes Highway south of Waterfall along the former Princes Highway to Lawrence Hargrave Drive at the junction with the Southern Freeway south bound ramps at Helensburgh Interchange. Then from the Southern Freeway north bound ramps at Helensburgh Interchange, along the former Princes Highway via Flat Rock Junction and Maddens Plains to the junction with the Southern Freeway and the Princes Highway near Sublime Point.

State Highway No 1	PRINCES HIGHWAY - From the City of Sydney at the junction of City Road and Broadway, via City Road and King Street, Newtown, then via St. Peters, Tempe, Arncliffe, Rockdale, Kogarah, Blakehurst, Tom Uglys Point, Sylvania and Waterfall to the start of the Southern Freeway at Waterfall, then from the end of Southern Freeway at Bulli Tops Interchange via Bulli Pass and Bulli to Bellambi Lane, then via Bellambi Lane and the Northern Distributor to North Wollongong interchange, then from the Northern Distributor at North Wollongong Interchange via Flinders Street, Wollongong, then via Keira Street and Crown Street, West Wollongong, then via Unanderra, Dapto, Oak Flats, Kiama, Berry, Nowra, Milton, Ulladulla, Batemans Bay, Moruya, Bodalla, Narooma, Cobargo, Bega, Wolumla, Pambula and Eden to the Victorian Border.
