1. Use this Form to obtain details of vehicles currently or previously owned by the Company.
2. We will advise you of:
 - vehicles currently owned by the Company
 - vehicles previously owned by the Company within the nominated search period
 - date the Company disposed of the vehicle within the nominated search period
 - price advised to us for the disposal
3. If you wish to obtain the name and address of the Buyer for a disposed vehicle then you must complete [Form 5633](#) (Vehicle Buyer Search). Normally you will need to complete this Vehicle Ownership Search Form first to identify vehicle ownership before applying for the Buyer search.
