



AIS - Unregistered Heavy Vehicle No Compliance Plate (Authorised Inspection Scheme)

When to use this form

This form is to be completed for unregistered heavy vehicles manufactured on or after 1/8/1972 that is not fitted with a compliance plate.
*Once completed a copy of this form and all appropriate documentation must be retained by the Authorised Inspection Scheme.

How to use this form

Column 1 must be completed using details taken directly from the vehicle, Column 2 must be completed using details from registration certificate, statement from registration authority, or import approval. See Important Notes below. Compare the information in Column 1 and 2 and where the information matches place a tick in Column 3.

- Where all of the boxes in Column 3 are ticked, the vehicle can be checked for registration. Attach this form to the Application for Registration (Form 1009).
- Where any of the boxes in Column 3 are not ticked or the information to complete Column 2 has not been provided or is not available, the vehicle at this point is not to be passed for registration. Email this form and any relevant documentation to the Transport for NSW Technical Enquiries unit technical.enquiries@transport.nsw.gov.au and then retain with the 'pink slip'. Issue the 'white slip' to the customer and advise that they will be contacted by Transport for NSW.

Note: It is the customer's responsibility to provide the appropriate documentation

- For vehicles previously registered in New South Wales advise the customer to obtain the required information from a Service NSW centre (T 13 22 13)
- For vehicles previously registered interstate advise the customer to obtain the required information from the Interstate Registering Authority (minimum of two years previous registration required)
- For imported vehicles advise the customer to contact the Department of Infrastructure and Regional Development to obtain a copy of the import approval (T 1800 815 272).
