- i. Be trading to provide approved marine type services to the boating public or a business which cannot be accessed by means other than water (ie: there is no land access).
- ii. **Provide, in writing, information/particulars relating to the purpose of the business and/or its shore based facilities.**
- iii. Provide Proof of Identity (POI) for both the applicant and nominated representative.

Commercial Mooring Licence fees are payable at the time the licence is issued. Transport for NSW will contact you regarding payment options.

Be the purchaser of a business with an existing Commercial Mooring Licence that provides an approved marine type services to the boating public or a business which cannot be accessed by means other than water (ie: there is no land access) and continue to utilise the Commercial Mooring sites in accordance with the approval.
- ii. **Provide, in writing, information/particulars relating to the purpose of the business and/or its shore based facilities.**
- iii. Provide Proof of Identity (POI) for both the applicant and nominated representative.

Commercial Mooring Licence fees are payable at the time the licence is issued. Transport for NSW will contact you regarding payment options.
