

2019 Easter Long Weekend Travel Requirements

Load carrying vehicles

Roads and Maritime Services | March 2019

Travel restrictions apply for oversize load carrying vehicles, such as low loaders transporting oversize equipment, during the Easter long weekend. These requirements are outlined in [the New South Wales Class 1 Load Carrying Vehicle Operator's Guide](#), the [NSW Schedule of the Multi-State Class 1 Dimension Exemption Notice 2016](#) and additional requirements for vehicles operating under an access permit in the [Additional Access Conditions for oversize and overmass heavy vehicles and loads](#). This document provides an overview of the Easter long weekend travel requirements.

Night time requirements

There is no change to night travel requirements for oversize load carrying vehicles during the Easter long weekend.

Load carrying vehicles up to 2.5m wide and 22m long are permitted to travel between sunset and sunrise.

Load carrying vehicles exceeding 2.5m wide and/or 22m long are permitted to travel when accompanied by at least one pilot vehicle:

- NSW Urban Zone – between midnight and sunrise on all approved roads
- NSW Regional Zone – on selected roads at times specified for each road. These can be viewed in [the New South Wales Class 1 Load Carrying Vehicle Operator's Guide](#).

Day time requirements

Oversize load carrying vehicles can travel in the day time during the Easter long weekend, subject to additional travel restrictions on specified roads in the NSW Urban and Regional Zones between sunrise on 19 April 2019 and sunset 22 April 2019.

Note: A Class 1 heavy vehicle transporting an agricultural cotton machine on Easter Saturday or Easter Sunday can travel on specific roads as outlined in the [NSW Class 1 Agricultural Cotton Vehicle Exemption For Permitted Heavy Vehicles \(Notice\) 2016](#).

NSW Urban Zone

Load carrying vehicles **exceeding 2.5m wide and/or 22m long** cannot travel in the day time between sunrise on 19 April 2019 and sunset on 22 April 2019 on the following roads (a vehicle travelling across a road is exempted):

Load carrying vehicles **exceeding 3.5m wide and/or 25m long** cannot travel on any State Roads* in the NSW Urban Zone in the day time between sunrise 19 April 2019 and sunset 22 April 2019.

NSW Regional Zone

Load carrying vehicles **exceeding 2.5m wide and/or 22m long** cannot travel in the day time between sunrise on 19 April 2019 and sunset on 22 April 2019 on the following roads (a vehicle travelling across a road is exempted):

In addition to the above restrictions, load carrying vehicles **exceeding 3.5m wide and/ or 25m long** cannot travel on any State Roads* in the NSW Regional Zone east of and including the Newell Hwy. Please note there are restrictions on sections of Kidman Way, Lachlan Valley Way and Burley Griffin Way **west** of the Newell Hwy (please refer to the above table).

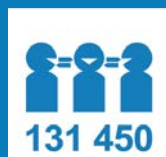
