

Investigation work on Garfield Road, Riverstone from Wednesday 1 July 2020

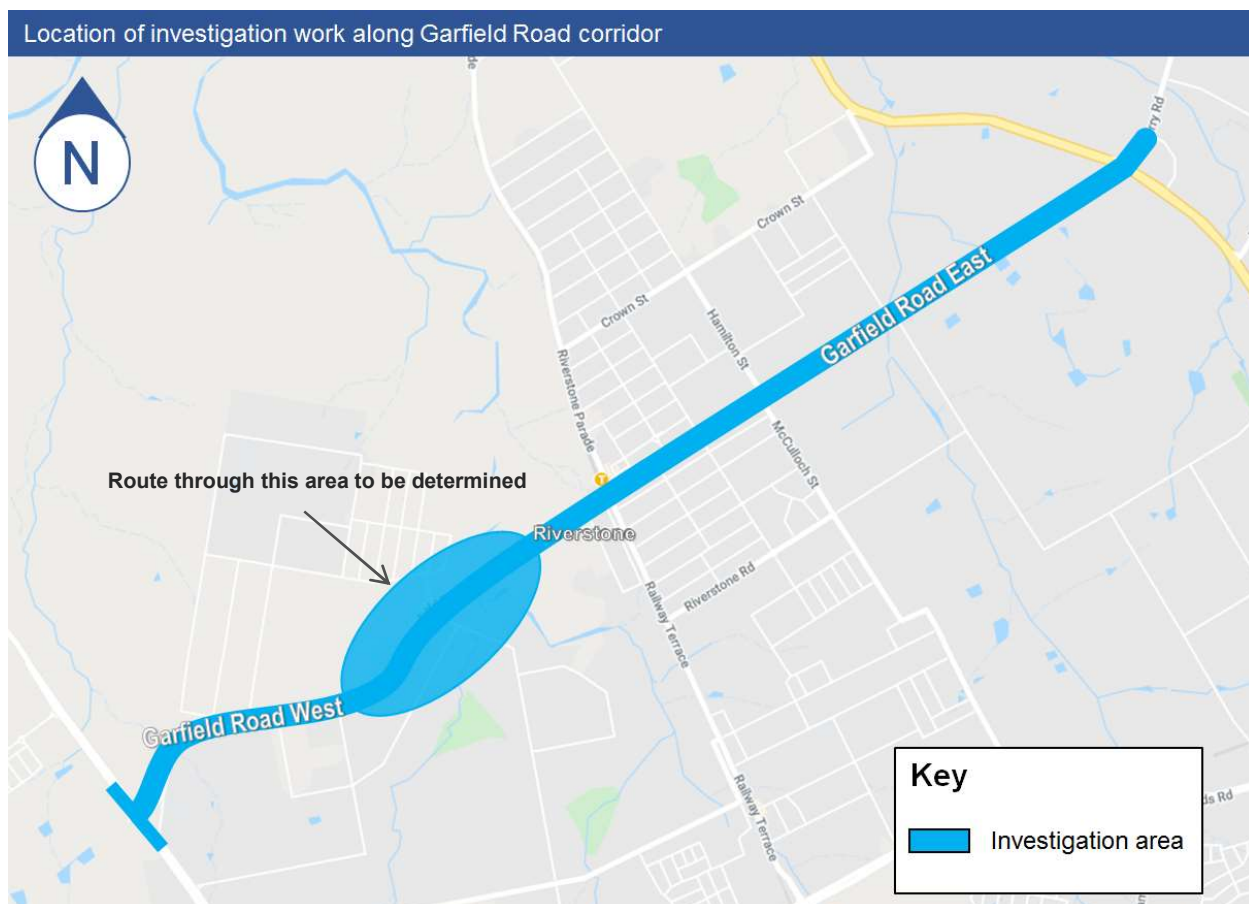
The NSW Government is carrying out investigation work to plan for future road projects in the Riverstone area.

Transport for NSW will continue to carry out investigation work on Garfield Road West and East, Riverstone. Our work will include surveying, geotechnical work, and traffic, utilities and environmental investigations.

These studies will help inform the design of future road upgrades of Garfield Road West and East.

Our work aims to:

- reduce congestion and improve traffic flow through the intersection and surrounding streets
- improve safety for motorists, cyclists and pedestrians
- improve connectivity between Richmond Road and Windsor Road.



Our work schedule

We will be on site from **1 July 2020 to 31 December 2020**.

Our work hours will be between **7am and 6pm** from **Monday to Friday**.

Work will not be carried out on public holidays.

The investigation work will be carried out within the road reserve or on private property along the road corridors. There may be some noise associated with this work, but every effort will be made to minimise the impact on residents.

There will be temporary traffic changes, including reduced speed limits and lane closures while the work is carried out.
